



### Guidelines for WRJ Microgrants

Women of Reform Judaism is proud to announce a microgrant opportunity for your WRJ-affiliated women's group. Any new or innovative project or program that relates to engagement or social justice qualifies for this grant opportunity.

There are currently two microgrant opportunities available. First, a women's group is eligible for a grant to engage women around timely issues in the pursuit of social justice, including any work related to WRJ resolutions or high-priority issues. Additionally, a women's group is eligible to receive a grant for a program or project that promotes engagement in the areas of sisterhood/community building, spirituality, or personal enrichment and growth. **Your program does not have to meet both criteria to apply.** Either engagement and/or social justice activities qualify for a grant. Multiple WRJ-affiliated women's groups may collaborate on a program.

Grants between \$500-\$2,500 will be awarded.\* A WRJ-affiliated women's group may only submit one grant proposal per year. The grant funds will be reimbursed after the program has been completed, unless other arrangements have been made.

#### Grant Guidelines:

**Microgrants will be awarded on a rolling basis. Applications for the 2024-2025 calendar year will open on November 14, 2024, and must be submitted by June 30, 2025.**

The program or project must be completed by **December 31, 2025**. Only new and innovative programs qualify. The program must have a significant impact for its target audience. Content, creativity, quality and innovation are all criteria for determining grant eligibility.

Multiple WRJ-affiliated women's groups may collaborate on a program. Only one women's group should submit the application, listing all participating groups. A program cannot be submitted more than once. In addition, we encourage you to partner with other groups within your congregation or community.

Your program/project must conclude by December 31, 2025. **Microgrants will not be awarded for ongoing programs, programs to fund the operations of the women's group or temple, or for funds used as a pass-through to support other organizations. Only one submission by a WRJ-affiliated women's group**

**is permitted per year. If the program is awarded a Microgrant, it will not be eligible to apply for an Or Ami Award.**

***Following the completion of the program, it is expected that the grantee write a 1-2 page grant report documenting the receipts and a statement of impact.***

#### Program/Project Focus

All programs/projects should have at least ONE the of the following themes as a primary focus:

- Engagement in the areas of sisterhood/community building, spirituality, or personal enrichment and growth
- Social Justice, including WRJ resolutions and high priority issues
- Leadership development
- Outreach to other groups
- Diversity, Equity, or Inclusion

#### Audience:

Identify your target audience and indicate how they will benefit from the program/project.

#### Impact:

Describe the positive impact this program/project will have on your target audience. Describe ways in which your program/project may create partnerships and build bridges with other groups or areas of your congregation. Describe how this opportunity will engage current or potential members.

#### Goals:

Clearly state your goals. Discuss how this project/program will achieve these goals and how you will measure success.

#### Evaluations:

Discuss what method you will use to evaluate the program/project once completed, including both quantitative and qualitative methods. (A Microgrants Committee member will contact you to evaluate and discuss the program once it is completed.)

#### Connection to WRJ

Your project or program must acknowledge WRJ and include WRJ branding.

#### **Who can apply?**

Any WRJ-affiliated women's group or multiple WRJ-affiliated women's groups who collaborate on a program may apply for a grant, as long as the project is initiated or executed by at least one WRJ-affiliated women's group. Only one women's group should submit the application, listing all participating groups.

#### **How to apply**

Carefully read the guidelines and application before beginning! **Once you begin an application, you will not be able to return to edit it, so you may want to prepare your responses in a word document first.**

**The deadline to submit a grant application is June 30, 2025.**

Winners will be notified of their grant award in writing by WRJ no later than 75 days after receipt of the submission.
